At A Glance

- Third largest health care provider in Marin, serving over 34,000 patients/year; almost 40% are children
- Clinics in Larkspur, Novato, and San Rafael (medical, dental, and teen)
- Nationally recognized Patient Centered Health Home model, which focuses on the patient/clinical team partnership
- Pediatric, Family and Adult Medicine – primary care, obstetrics and gynecology, family planning, behavioral health, and specialty care
- Pediatric and Adult Dentistry
- Optometry, Radiology, Pharmacy, Lab, Chiropractic, and referrals to specialists
- Weekly Community Health Hubs with fresh food pantries
- Over 490 staff (390 FTEs), including doctors, dentists, nurses, and other clinicians
- Accepts Medi-Cal, Medicare, Covered California, and other insurances; patients without insurance receive sliding scale discounts
- Not-for-profit, supported by individuals, foundations, businesses, government grants, and public insurance reimbursement

A SPECIAL MESSAGE FROM THE CEO

Now, more than ever, the national health care scene is having a direct impact on the country's community clinics and their patients.

The proposed "public charge" legislation is one example. Many patients, acting out of fear and misunderstanding, are missing appointments and disenrolling in public support programs such as Medi-Cal. Community clinics across the U.S. are concerned about their sustainability, given reductions in Medi-Cal enrollment and the related decrease in federal funding. If the public charge legislation is enacted, California's community clinics are projected to lose an estimated 102,000-195,500 patients and \$126-240 million in revenue.

On a broader scale, the ongoing uncertainty about the future of the Affordable Care Act continues to create instability for patients and healthcare providers across the spectrum.

Our Steadfast Commitment to Our Patients & Sustainability

Although the number of uninsured Marin residents continues to escalate, Marin Community Clinics remains steadfast in its commitment to serving those in need. We are not only closely monitoring public policy developments, but also taking action.

We've stepped up our advocacy efforts in support of patient access and are working hard with our partners to stem misinformation and fear. Importantly, we are financially strong and forward-thinking, and are putting plans in place to ensure our sustainability for the long-term. Rather than relying on Medi-Cal reimbursement as our major source of financial support, we are looking to broaden our patient population to include more patients who are covered by Medicare and other insurance plans and who need a primary care provider. New statewide programs are also part of the solution (see page 2) and community fundraising will continue to play a strong role.

It is not an easy time, but we are up to the task! And, thanks to the efforts of our Board of Directors, strong fiscal management, committed staff — and your strong support — we are on solid ground.

New Statewide Pilot Project to Improve Patient Access

The Clinics has been selected to participate in a statewide pilot project that will increase access to care for indigent, uninsured, and undocumented adults who are not otherwise eligible for state support. Funded by the California County Medical Services Program (CMSP), the "Path2 Health" project includes a community outreach component as well as subsidized preventive and primary care.

Marin Community Clinics will serve as the Marin provider and receive reimbursement for services; we are collaborating with Canal Alliance and North Marin Community Services on the outreach component.

Several days/week, she performs outpatient procedures and cares for high risk pregnant moms; other days, she works at MGH - delivering babies, supervising nurse midwives, performing surgeries, and seeing our patients in the emergency department. As a lead Clinics obstetrician, she is also creating protocols for our pre-natal program and bringing her expertise in infertility treatment and laparoscopic surgery.

Expertise — and Passion

Dr. Byer has a strong passion for her work. In high school, she knew she wanted to work in the medical field. Later, volunteering in an inner-city children's hospital and with Rotacare in Belize "hooked" her on a career in medicine.
